**#24 count intro - CW - 2 RESTARTS - 4 TAGS - ENDING**

**SECT.1 TRIPLE STEPS R FWD DIAG. R, 1/4 TURN R TRIPLE STEPS L BACK, 1/4 TURN R TRIPLE STEPS R FWD, 1/8 TURN R TRIPLE STEPS L SIDE**

**1&2**walk R to R diagonal, walk L beside R, walk R to R diagonal (1.30)

**3&4**1/4 turn R back L, back R beside L, back L (4.30)

**5&6**1/4 turn R walk R, walk L beside R, walk R (7.30)

**7&8**1/8 turn R step L to L side, step R beside L, step L to L side (9.00)

**SECT.2 HOOK COMBINATION R, COASTER STEP R BACK, STEP L DIAG., SWIVEL R HEEL & TOE, STEP R DIAG., SWIVEL L HEEL & TOE**

**1&2**touch R heel fwd, hook R over L, touch R heel fwd (weight on L)

**\*Restart here walls 8 (6.00) & 12 (12.00)**

**3&4**back R, back L beside R, walk R

**5&6**walk L to L diagonal, swivel R heel to L foot, swivel R toe to L foot (weight on L)

**7&8**walk R to R diagonal, swivel L heel to R foot, swivel L toe to R foot (weight on R)

**SECT.3 SAILOR STEP L WITH 1/2 TURN L, LOCKED TRIPLE R FWD, 1/4 TURN L, LOCKED TRIPLE L FWD, COASTER STEP R FWD**

**1&2**cross L behind R, 1/2 turn L step R to R side, step L to L side (3.00)

**3&4**walk R, walk L locked behind R, walk R

**5&6**1/4 turn L walk L, walk R locked behind L, walk L (12.00)

**7&8**walk R, walk L beside R, back R

**SECT.4 TRIPLE STEP L BACK, TRIPLE STEP R BACK, SAILOR STEP L WITH 1/4 TURN L,  
STEP 1/2 TURN L**

**1&2back L, back R beside L, back L**

**3&4back R, back L beside R, back R**

**5&6cross L behind R, 1/4 turn L step R to R side, step L to L side (9.00)**

**7-8walk R, 1/2 turn L (weight on L) (3.00)**

**\*Tag here walls 3 (9.00), 6 (6.00), 9 (9.00) & 10 (12.00): 1-4 JAZZ BOX R**

**1-2cross R over L, back L**

**3-4step R to R side, walk L**

**\*ending here wall 13 (3.00): on counts 7-8 do 3/4 turn L**
