## Start on the word Luckenbach

### SIDE, TOGETHER, SIDE TRIPLE STEP; CROSSOVER ROCK STEP, SIDE TRIPLE STEP

- 1-2      Step Right to right; Step Left beside Right
- 3&4      Step Right to right, Step Left beside Right, Step Right to right
- 5-6      Rock Left across Right; Recover back onto Right
- 7&8      Step Left to left, Step Right beside Left, Step Left to left (12:00)

### CROSSOVER, SIDE, SAILOR STEP; CROSSOVER, ¼ TURN, COASTER STEP

- 1-2      Step Right across Left; Step Left to left
- 3&4      Sailor step Right, Left, Right
- 5-6      Step Left across Right; Turn ¼ turn left stepping Right back (9:00)
- 7&8      Step Left Back, Step Right beside Left, Step Left forward

### FORWARD ROCK STEP, BACKWARD TRIPLE STEP; ½ TURNING TRIPLE STEP, STEP ¼ TURN

- 1-2      Rock Right forward; Recover back onto Left
- 3&4      Triple step backward Right, Left, Right
- 5&6      Turn ½ turn left & triple step forward Left, Right, Left (3:00)
- 7-8      Step Right forward; Pivot ¼ turn left onto Left (12:00)

### CROSSOVER TRIPLE STEP, SIDE ROCK STEP; CROSSOVER TRIPLE STEP, ½ TURN HINGE TURN

- 1&2      Step Right across Left, Step Left to left, Step Right across Left
- 3-4      Rock Left to left; Recover right onto Right
- 5&6      Step Left across Right, Step Right to right, Step Left across Right
- 7-8      Turn ¼ turn left stepping Right back; Turn ¼ turn left stepping Left forward (6:00)

## START OVER

**TAG: After the second wall add the Tag & start over: (12.00)**

**FORWARD ROCK STEP, COASTER STEP; FORWARD ROCK STEP, COASTER STEP**

- 1-2**        Rock Right forward; Recover back onto Left
- 3&4**        Step Right back, Step Left beside Right, Step Right forward
- 5-6**        Rock Left forward; Recover back onto Right
- 7&8**        Step Left Back, Step Right beside Left, Step Left forward
